MN South District is continuing to see low attendance in a number of congregations, opportunities to come alongside the district and local congregations will likely continue to exist. Of the roughly 225 congregation in the Mn. South District half are worshipping 70 or less. Liberty Ridge: A permanent structure is continuing to be evaluated. Sprung structures have been connected with the city of Afton to see if a structure like what they build would be allowed. Trigger points are being determined for when it would be appropriate to move forward with building. In May we will meet for a strategic planning retreat. Pastor Tom will send a doodle poll for the council to meet for strategic planning. 	 Action – Liberty Action Team will continue to explore the ability to build a Sprung Structure on Afton land.
